

## **VISA REQUIREMENTS**

1. To apply for a visa, you must **fully complete the online application form**. Visit the Official Non-Resident Visa Application Form on the consular section webpage, which redirects to the Ministry of Foreign Affairs of Paraguay. The webpage also provides additional details about visa requirements.

You will need to upload the following documents as part of the application process:

- A 3x4 passport-sized photo in JPG format, recent, with a white background, front-facing (not profile) without accessories;
- Color image of the passport (front and last page);
- Color image of visas granted by other countries, including electronic visas;
- Invitation letter from a natural or legal person, domiciled in Paraguay (if the case).  
Please note that legal entities in the private sector domiciled in Paraguay that invite citizens requesting visas in the tourist and technical subcategories must submit their invitations letters addressed to the authorities indicated below and **present them to the Passport and Consular Services Directorate of the Ministry of Foreign Affairs in Asunción<sup>1</sup>**:

- If invited by an educational, religious, sport institutions or individuals you must attach an Invitation letter indicating telephone contacts, email, and purpose of the visit, and a copy of the Paraguayan identity card of the signer, authenticated by a notary.
- Proof of economic solvency: personal bank statement of the last 3 months. **The original copy must be provided with bank seal and sign.**
- Police record certificate from your country of residence, properly legalized and/or apostilled;
- Hotel reservation and/or accommodation;
- Flight itinerary or tickets for land transportation and/or declare the way of entry to Paraguayan territory;
- A Personal /Company visa Request letter

2. The consular office and/or the Directorate of Passports and Consular Services of Paraguay may request additional documentation.

If the application was completed correctly, the visa applicant will receive an email informing them that their application was generated correctly and it will be verified by a consular office. After the first review, if applicable, you will be assigned a date and time for an interview, which will be sent to the email address provided in the application form.

3. The passport must have at least two blank pages and Passport should have **minimum validity of six months** from the intended date of entry in to Paraguay.

**Visa applications must be submitted at least thirty (30) days prior to the intended date of travel, counting from the moment the application file is complete and all required documentation has been duly submitted.**

**If coming from outside of India, it will be necessary to bring photocopy of Indian Visa and immigration stamp of entry into India.**

**SANITARY REQUIREMENTS:**

Every traveller who arrives in Paraguay from risk areas: Brazil, Bolivia, Colombia and Peru, must be vaccinated against yellow fever and have the international vaccination certificate that proves it in accordance with Resolution SG No. 871/2024 of the Ministry of Public Health and Social Welfare of Paraguay (<https://dgvs.mspbs.gov.py/salud-del-viajero/requisitos-para-ingresar-a-paraguay/>)<sup>2</sup>.

**For a minor there are a few additional documents requested by the corresponding institution stated as follows:**

Minors under 18 years old cannot apply for a visa on their own. In such cases, the process must be carried out by the parents or legal guardians, completing the digital visa application form. If the parents or legal guardians do not travel with the minor, they must provide written travel authorization according to the formalities of the country of residence.

**Please Note**

- The Visa fee is U\$D 100.00 (valid for multiple entries). Please Note: Visa fees should be paid only after having been informed of visa approval by the visa officer, who will also indicate where the bank deposit/transfer should be made. Deposits are made in Indian Rupees.

**VISA EXEMPTION FOR MALAYSIAN CITIZENS**

Pursuant to Decree No. 5220 of 29 December 2025, nationals of Malaysia holding a valid passport may enter and stay in the Republic of Paraguay without an entry visa **for a period of up to 30 days** per entry.

An entry visa is required for Malaysian nationals who intend to remain in Paraguay for more than 30 days.

### **VISA ON ARRIVAL FOR THAI CITIZENS**

Pursuant to Resolution No. 1031 of 17 December 2025, nationals of the Kingdom of Thailand holding a valid passport are eligible to obtain a Visa on Arrival in Paraguay, issued at the “Silvio Pettrossi” International Airport, under the Non-Resident (Tourist) category, for a maximum stay of up to **fifteen (15) days per entry**. The visa fee is USD 100 (one hundred United States dollars).
